**Subject: Minutes of the Meeting of Technical Evaluation Committee (TEC) held on 29th June 2022 at 3:00PM under the Chairmanship of Secretary (IT), to evaluate the IT proposals of various Departments of Govt. of N.C.T. of Delhi through Video Conferencing amid Covid-19 pandemic.**

- I.** The meeting of TEC was held on 29<sup>th</sup> June 2022 and conducted through Video Conferencing amid COVID-19 Pandemic.
- II.** The TEC meeting Agenda approved by the Secretary(IT) is annexed as **Annexure-I**
- III.** The copy of the TEC's meeting notice is annexed as **Annexure-II.**

- V.** The proposals of the various Departments as per meeting agenda and decisions taken/advice of the Technical Evaluation Committee are described below:

**1. Department Name: - Information Technology Department**  
**F.No.-E-H/1/2019-Admin-Secy(IT)**

Two proposals of the Information Technology Department, GNCTD for seeking technical clearance of TEC for **Hardware required for Upgradation of NIC Net Connectivity from 1 Gbps to 10 Gbps** and **Revamping of LAN and Wi-Fi in Delhi Secretariat**, are put in TEC.

TEC discussed the both the proposals in details as per the agenda item no **1(Proposal-1) & 1(Proposal-2)** mentioned in attached Annexure-I and noted that as per the Standard Technical Specifications circulated by IT Department, the specifications given by NIC Delhi State Unit in respect of Router/L2 and L3 switches and other networking equipment are to be used.

TEC also suggested and agreed for revamping of the LAN and Wi-Fi and enhancement of bandwidth from 1 Gbps to 10 Gbps in view of the 100% implementation of e-Office in Government of Delhi as it requires speed and uninterrupted internet service (NICNET) for smooth functioning of the e-Office system.

The proposal is as per the recommendation of NIC Team and hence approval of TEC is not required. Department can procure the required Hardware relating to the proposal based on NIC Team.

Further TEC also advised to utilize the existing 60 Wi-Fi access points till the end of support by OEM and procure the additional number (as per survey) of new Wireless access points along with other proposed equipment in the first instance to cover the remaining blinds spots in the Secretariat. It was also noted that most of the refurbishment of chambers in Secretariat is completed/nearing completion, hence it's advisable that IT department may initiate the procurement of new Access points, switches -etc. for seamless WiFi and LAN connectivity. Further the Department shall ensure to replace the existing 60 wi-fi Access points 15 days prior to their end of support period given by OEM i.e. April 30, 2024.

The proposal has been examined in the light of various circulars issued by IT Department and observed the following: -

- a) IT Department vide its order No. F.10(135)/2009/IT-Part File/3879-3950 dated 5.8.2020 authorized the Administrative Secretaries and Concerned Minister In-charge to decide the Operating System and/or Screen Size as per the functional need and categories of incumbent officer/authority as the case may be. In such cases IT Department need not be approached for technical clearance.
- b) Further TEC vide its minutes dated 23.6.2022 observed that the specifications of iMAC viz were not fully matching with the latest standard specifications published by IT Department in respect of All-in-One/Desktop and recommended that the same may be treated as relaxed for iMAC make till further circular/order issued by IT Department so that the other departments need not approach IT Department for seeking approval of TEC for procurement of such type of IT devices.
- c) IT Department vide its circular No. F.6(375)/IT/2014/5555-5729 dated 10.8.2014 allowed Departments to procure Office suite as per their requirement and hence approval of IT Department is not required for procurement of MS Office.






