# 1. Directorate of Economics & Statistics

The proposal of Dte. of Economics for procurement of IBM – SOSS software , 6 user license was technically approved by TEC.

# 2. Urban Development

The proposal of UD Department for procurement of 24 Desktops and 20 Printers for its various branches was technically approved by the TEC.

#### 3. Education Department

The TEC technically approved the hiring of 6 Assistant Programmers on contract basis, with the direction that posts be created through AR Department.

#### Proposal -B

The TEC technically approved the procurement of below mentioned hardware subject to the condition that the administrative Department will first send the Condemnation and Auction Report to IT Department, then purchase the hardware.

### 9. Satyawadi Raja Harishchandra Hospital

The proposal of the Hospital for installation of hardware for video conferencing was discussed in TEC. The Committee observed that it was an administrative decision of the department and TEC had no role in it.

# 10. Maulana Azad Medical College Proposal -A

The proposal of MAMC for procurement of 31 laptops for newly instituted laboratories & LT/Demonstration rooms was technically approved by TEC.

#### Proposal -B

The second proposal of MAMC for upgrading of its existing network, was technically approved by TEC.

# 11. GB Pant Engineering College

The proposal for setting up of Lab for advance software quality testing for imparting practical training, was discussed in TEC. The Chairman TEC directed that Sh Manjhi from GB Pant Engg College may be called discussions. Mr. Deepak Sharma, HoD, Mechanical Department discussed the requirement of the product. TEC approved the requirement with following conditions –

- a) Only Academic versions will be procured, judiciously.
- b) The procurement of software shall be done only through OEM.
- Proprietary Certificate from OEM should be obtained and placed on record, before procurement.
- d) Reasonability of cost shall be ensured before placing the order.

# 12. Indira Gandhi Delhi Technical University for Women

- The proposal for upgradation of existing networking with fiber optic networking ( High Bandwidth Access Point with IEEE 802.11n technology having utpo 450 mbps shared bandwidth) was technically approved.
- The proposal for implementing cloud-computing based integrated smart solution for campus management was discussed. TEC decided that IT Department should examine the best solution for all the universities.

# 13. Delhi Technological University

The DTU submitted the following proposals for procurement of proprietary softwares before TEC, for consideration:-

- Procurement of Govt Administration Management System Software "Pay Package" administrator module by DTU. The software used in Delhi Govt Deptt is a copyright of Ms Ultrasoft Tech India and is approved /empanelled package in Kendriya Bhandar with validity upto 31-12-2014.
  - Procurement of user license of "Netsim Standard Simulation Software" for Computer vision lab, E &C Department.
  - Procurement of proprietary software "Profession Version (2D and 3D) Visual TCAD & Genius Device Simulator and Workstation-1 Professional + 1 Basic Permanent License in Microelectronics Research lab, Applied Physics Department.
  - Procurement of 10 user license of proprietary software "Flow Code V6 Profession Software-Academic Version" for simulation lab, Electrical Department. Certificate of propriety is placed in the file.



TEC approved the procurement of the above softwares subject to the condition that:

- a) Only Academic versions will be procured, judiciously.
- b) The procurement of software shall be done only through OEM.
- Proprietary Certificate from OEM should be obtained and placed on record, before procurement.
- d) Reasonability of cost shall be ensured before placing the order.

#### 14. Food Safety

The proposal for procurement of 10 Data Cards with 3.1 Mbps speed for its Food Safety Officers for submitting online inspection reports, was technically approved by TEC.

#### 15. Department of Food and Supplies

- A proposal has been received from Department of Food & Supplies for extension of hiring of services of 90 Data Entry Operators for one more year w.e.f 17-06-2014 to 16-06-2015, against vacant posts of LDCs was approved by TEC.
- 2. The proposal for continuation of hiring of 10 Asst Programmers for implementation of e PDS portal containing Ration Card Management System (RCMS) Supply Chain management System and national Food Security Portal was approved by TEC. The Department should however get the required number of posts created through AR Department, if the nature of work is of permanent nature, instead of seeking extensions every time.
- 3. The proposal for finalizing of an agency for installation of CCTV 7 Video conferencing equipments in the Departments having heavy public interface was discussed in TEC. It was informed that ECIL was installing CCTVs in Transport Department. Other departments, if they so desire can use the standard Transport tender document and get CCTVs installed. IT Department does not have any role in it.
- F&S had proposed to procure 35 Desktop Computers for its various branches. TEC asked for the details of the IT Infrastructure in the prescribed Performa. The Department may send the file in next TEC meeting.
- 5. The proposal for selection of agency for computerization of FPS operation was discussed in the meeting. The representative from NISG, who have prepared RFP was also present in the meeting. Chairman TEC asked NISG to give in writing that sufficient bandwidth is available and there would not be any issues in flow of data with NIC infrastructure. The NISG shall be liable to penalty if the system is incapable of handling the data flow.
- 6. The proposal for Installation of Bio Metric Machines in F &S was discussed in TEC. TEC does not provide the post facto approval for an IT Project. However, the configuration of the biometric machines as per standards. F&S Department is to ensure the operational requirements are met by the machines.

# 16. Law, Justice and Legislative Affairs

The proposal for procurement of the following IT equipments for O/o District & Session Judge, against condemnation was in principle approved by the Committee:-

TEC however advised that the purchases be made in phased manner. The 100 computers which have been condemned may be auctioned first before placing the order for procuring equal number of computers. The next 100 equipments may be procured in the same manner, so on and so forth.

B. The proposal for empanelment of firms for providing the Data Entry Work /service and manpower in various Departments of Govt of Delhi, was discussed in detail. TEC returned the proposal of the DIT with the following observations:-

The DIT was calling technical bids only. The different departments seeking DEOs have to seek financial bids individually, resulting in different pay packages to DEOs for the same jobs. TEC directed that the file be first sent to Finance Department for advice.

# 18. Principal Accounts Office

The proposal of PAO for continuation of hiring of services of 3 Programmers, 14 Asst Programmers and 30 Data Entry Operators for one more year w.e.f 21-06-2014 was technically approved by TEC.

TEC however observed that it has become a tendency on part of PAO to create employment. The PAO should get the posts created through AR Department, if it really requires that much IT manpower.



#### 19. Trade & Taxes

The proposal for procurement of 300 Tablets for VATI/AVATO/VATO against condemnation of old outdated hardware was discussed in the meeting. TEC suggested for a smart way of storing data of dealers in such a way that there is minimal requirement of bandwidth for handling of data. TEC approved in principle the requirement and asked that procurement may only be done when obsolete IT equipment is condemned and auctioned by the Department.

#### 20. Rohini Jail

The proposal for LAN connectivity between Prison Head Quarter and Rohini Jail was technically approved by TEC.

#### 21. DSSS Board

The following proposals of DSSSB were discussed in TEC meeting:-

- 1. Implementation of online Computer based examination system
- 2. Essential requirement of customization and support for OARS for the period 2014 15.

The RFP was approved in principle by the TEC. TEC further directed that the agency identified for conduct of exams online should have experience of conducting at least two exams in Delhi.

- IV. The approvals by this Committee (TEC) are subject to the condition that the respective Departments shall complete all codal formalities as per Rules and Regulations including financial instructions / guidelines for calling of tenders (as per GFRs etc) in this regard.
- V. The above approvals are also subject to the condition that all the above said Departments shall have to take approval of Finance Department, wherever necessary, in accordance with Cabinet Decision No. 1585 dated 03.11.2009.
