<u>ORDER</u>

The Information Technology Department has cadre strength of 348 posts {Joint Director (IT) - 04, Senior System Analyst - 16, System Analyst - 43, Data Processing Assistant - 142 and Data Entry Operator Grade-D - 20, Data Entry Operator Grade-B - 71 and Data Entry Operator Grade-A – 52} under its administrative control working in various Departments of Government of NCT of Delhi. The Data Entry Operators (DEOs) have been demanding for their cadre review on account of stagnation and lack of promotional avenues. In order to have IT Cadre review of Govt. of NCT of Delhi, a Committee under the Chairmanship of Secretary (IT) was constituted on 20-04-2018.

Subsequently, the Delhi Administration EDP employees Welfare Association (Regd.) filed O.A. No. 2853/2021 & M.A. No. 3475/2021 before the Hon'ble Central Administrative Tribunal seeking orders of expeditious review of their cadre. The Hon'ble CAT vide order dated 11-07-2022 had issued the following directions: -

"The Competent Authority take a final decision on the issue of Cadre Review of DEOs, within a period of four months from the date of this order"

It was felt that there is a need for complete restructuring of IT Cadre for strengthening and meeting the requirements of emerging technologies. Accordingly, Chief Secretary, Delhi vide order dated 09-09-2022 had constituted a High Level Committee (hereinafter referred as HLC) under the Chairmanship of Addl. Chief Secretary (GAD) / Addl. Chief Secretary (AR) with Secretary (IT), Secretary (Finance), Special Secretary (AR-I/AR-II) and Special Secretary (Services) as member for working on strengthening of I.T. Cadre for all departments. The HLC has submitted their recommendations vide report dated 03-03-2023.

The HLC also constituted a Sub-Committee to study about existing IT Cadre structure and propose new revised structure of IT Cadre. The Sub-Committee recommended to open recruitment of Data Entry Operators, which was discontinued way back in 2004. The three categories of Data Entry Operator i.e. Grade-A, B, & D and additional posts of DEOs have been recommended to have faster promotional avenues. In addition, it has recommended that 20% posts of DPAs shall be a promotional quota for Data Entry Operator, thereby providing them promotional avenues. It also recommended change in nomenclature of Data Entry Operator as IT Assistant and creation of additional 137 posts of IT Assistants. The RRs, in this regard shall be finalised in consultation with UPSC in due course. These recommendations of Sub-Committee were endorsed by the HLC and included in its report.

Further, the HLC underlined the emergence of new technologies in the field of IT related to advanced technologies in specialised domain viz. Cyber Security & Data Security, Cloud Computing, Computer Network, Procurement and Contract Management and Data Sciences. It has highlighted the need to have experts in these specialised areas to cater to the needs of various departments of Govt. of NCT of Delhi. Accordingly, the HLC has recommended the creation of Specialised Cadre within IT Cadre in addition to the existing IT Cadre i.e. Generic IT Cadre.

The Government has accepted the recommendations of the HLC.

Accordingly, Hon'ble Lt. Governor, Delhi is pleased to sanction the creation of 571 posts i.e. Generic Category-263 posts, Specialised Category -171 posts, IT Assistants-137 on regular basis in different categories under IT cadre of Information Technology Department, GNCTD. The details are as under:
